- C. **Our Claims** means all acclaims of any sort which I may have or may later obtain as a result of bodily injuries, death or property damage arising or alleged to arise from my participation in the **Annual Rally Up North** ("the Event") even if the claims arise out of the Sponsors' own negligence. My Claims include, but are not limited to, claims for personal injuries, death, property damage, pain and suffering, medical expenses, income loss and loss of earning capacity, punitive damages, loss of consortium, attorney fees, costs and any other claims of any sort which I have, or any Other claims of any claimed to arise our participation in the Event.

RELEASE
